PRESIDENT'S MESSAGE

Our table at the Baxter County Fair did OK with charity sales and selling tickets for our raffles. It could have been better but perhaps some people didn't attend due to rain on a couple of days. We have only one more event that we can sell raffle tickets at and that is the Hillbilly Chili Cookoff on Oct 15th. If the Woodturners have their show this year we may sell additional charity items. Last year it was held after we already selected the winning ticket for the raffle items. We'll see what happens this year after we get the date for their show.

At our board meeting we discussed raising our membership fees from \$15 member, \$5 spouse to \$20 member, \$5 spouse. Dues have not been raised for many, many years. Here is what our club pays for each year:

\$2,860 yearly (\$55 per week) to the VFW for rent, \$500+ for club insurance, \$500+ for the wood storage unit, about \$150 a year for Pot Luck drinks, Perhaps \$100+/- for meat at our August Pot Luck. Then there is Christmas party related costs, our post office box, our bank safety deposit box, office supplies, get well cards, stamps, wood for our beginner programs, etc. Last year we even donated \$400 of our club money to add to the \$1,200 charity money.

Our yearly raffle is how money is made for our club and this year so far we have made less money due to missing Gassville-in-the-Park, History Days, and possibly the Woodturner's Show. Please consider this at our next regular meeting when we will vote on it. It will only cost less than 10 cents a week extra.

Ray thanked all the members who had entered carvings at the County Fair. He also thanked the carvers who had contributed carvings to the charity table.


