## General Membership Meeting of February 16, 2012 MINUTES

The meeting was called to order by the president, Paul Baumann, at 10:30. The Pledge to the Flag was followed by the acceptance of the minutes of the last meeting as published in *The Chip Pile*. The Treasurer's report was accepted as read. The Librarian, Betty Gregory, called attention to a table featuring sample items from our library. She said that each week the table would contain a new exhibit.

Kathi Clark reported that we now have 131 members. Sandy Smith requested carvings to be used as door prizes at the show. The show also needs items for the silent auction at the banquet.

Deb Moffett said that the VFW would provide several menu choices for our Christmas party.

The Quilters will come to talk to our club on March 8. Paul asked for suggestions for wood to be ordered for the club. He also said that we are in need of carved items to be sold for our charities.

Paul said that in order to meet the organizational test for exemption under section 501(c)(3), our Articles

of Incorporation must be amended to include the following provisions:

- a. *Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.*
- b. *Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.*

We are required to file this statement with the Secretary of State for Arkansas to keep our new 501(c)(3) rating. The statement was read, voted on, and accepted unanimously.

Show and Tell followed. Sandy Smith carved oak leaves and acorns on a butternut shelf in a class in architectural carving. Betty Gregory carved a polar bear cub on a shelf square and a bell. John Gregory showed a tiger on a shelf square, a bottle stopper, and a bark carving, all painted with oils. Jackie Miller carved a buffalo shelf tile and a wood burned pinecone circle for the clock. Deb Moffett showed a relief scene carved in Mary Waldeck's class and a sunflower circle for the clock. Naomi Inglett carved Christmas ornaments to be used as door prizes at the show. Kathi Clark carved a cute basswood mouse. Marty Wells showed a "hillbilly condo" bark carving, a deer on a shelf square, and a relief snowman. Ray Moffett carved a relief scene in Mary Waldeck's class and a relief called "Ray's Get-Away". Ken Doran showed "Disciple", carved in a cypress knee and a cottonwood wood spirit. Sid Edelbrock carved an eagle shelf square.

Sid Edelbrock won the Show and Tell drawing; Rick Heydt won the Name Tag drawing; and Bob Axel won the 50/50. The meeting, which was followed by a potluck lunch, was adjourned at 11:00.
