Paul Baumann carved stuff just to practice painting. Naomi Inglett, six Christmas spools to be presented to the Show Committee.

Show and Tell winner was Pat Walsh. Name tag winner was Penny Wells, and 50/50 winner was Marjorie Clements.

The meeting adjourned at 11:05.

# Board of Directors Meeting of February 5, 2015

## MINUTES

The meeting was called to order by the president, Ray Killen at 10:00. Rod Engle gave the treasurer's report which was accepted. There was a discussion about the safe deposit box and it was decided to leave it as it is.

Sonia Nelson, librarian, reported that many of the carvers who borrow books do not fill out the cards. This will be mentioned at the General Membership Meeting.

Curt Shirkey reported that our membership is now 129. Thirty-five letters were sent out reminding members that their dues are due.

Paul Baumann is currently teaching a pencil carving class. There was also a discussion on bringing in carvers to teach classes to our members.

The Noah's Ark Pre-School would like one of our carvers to give a carving demonstration to its students. Sonia Nelson volunteered to give a demonstration.

Sandy Smith, reporting for the Show Committee, said that they have sent out applications for the May 2&3 show.

Bob Shaffer said that he has an order in for tools. Paul said that members have until the end of March to get in special orders for wood to be delivered at the show. He

also said that we will decide on the order for wood for the club by the March meeting.

Ray said that there are two chess pieces that need to be returned by February 26. Len Kieltyka has painted the manger backdrop for the nativity. Sandy said that the "In God We Trust" carving project for the county courthouse is on hold until we hear back from the county judge.

Curt Shirkey reported that the knife sharpener is in need of repair. He suggested that we purchase a new Burke sharpener and have it delivered to the show, saving us the shipping cost. The Board will recommend purchasing a new sharpener at the next membership meeting.

Ray reminded the Board that Gassville in the Park is June 6. We will have two tables there.
