Quartermaster Paul stated that he would bring wood on the 3rd Thursday in June for members.

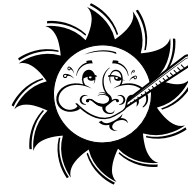
Tool Person Linda Lopin stated that we have tools and that the charge for the beginners class/tools/wood is appropriate.
